


**Objectives**

The Sabaragamuwa Chamber of Commerce & Industry (SCCI) is a body incorporated under the Companies Act No. 07 of 2007. The rules are regulations for operation of the Chamber are laid down in the Memorandum of Association and the Memorandum of Articles. The SCCI is governed by Director Board comprising of 17 elected members. Members are elected for a limited period according to rules as spelled out in the Memorandum of Articles.

Board of Directors takes overall responsibility in deciding the policy, planning implementation and monitoring of all activities, staff recruitment and determination of staff responsibilities, contracting or entering into agreements with external parties and in functioning as the custodian of all physical and financial resources of the Chamber. Internal administration and implementation of all programmes falls under the purview of the General Manager. The SCCI maintains an external pool of Consultants whose services are obtained by the General Manager as and when necessary not only in relation to project activities but also in deciding administrative and in interpretation of policy guidelines.
